2. The documents produced by School Management relating to documents along with Affidavits, the recommendation made by District Education Officer (S.S.) Tarn Taran and Director Education Department (S.S.), Punjab Chandigarh have been taken into consideration, No Objection certificate can only be issued by Punjab Government after fulfilling the following conditions:-

1. In future if any Complaint / inspection came into existence and at the time of getting No Objection certificate, if it is found that you have given false information or if you have not followed the instructions given by Punjab Government from time to time and you have not followed the conditions as laid down in the affidavit, in that event No Objection certificate can be withdrawn.
2. In your school Punjab subject is compulsory required upto the 10th standard and C.B.S.E. New Delhi can make it compulsory for getting examination of this subject.. If this procedure is not followed, in that event No Objection certificate can be withdrawn.
3. School Management, Education Department shall follow the R.T.I. Act, 2009 Notification and R.T.I. Act, 2009 enforced by Punjab Government.
4. After getting C.B.S.E. New Delhi Affiliation, School Management, Teaching and Non teaching staff of the school will get Salary and other perks by payee account Cheque like wise other Government employees. If this

procedure is not followed, No Objection certificate shall be withdrawn immediately. 5. You personally as well as your Management should make it assure that in your District Education Officer or Education Department or any other Senior official as and when sought any information, requisite information should be supplied and also to extend full cooperation to them.
