Sub :- Approval for free & compulsory education rights of children under rule 11 of sub rule (4) under the Free & compulsory Children Education Act, 2009 under section 18.

Respected Sir/Smt. Ji,

In view of the attached self declaration and inspection report of school submitted by the inspection team, the approval for Pre-primary to 8th standard is being given to Shaheed Baba Deep Singh Public School, Pahuwind which is opened by Shaheed Baba Deep Singh Educational Society from Pre-primary to 8th standard till March, 2019.

The above said approval is on the basis of following terms and conditions :-

1. The approval is not extendable and on any circumstances it should not take mean that this approval is the compulsory for the higher classes from 8th standard.
2. The school will comply with the terms and conditions of free and compulsory education of the children of school under Act, 2009 (serial-1) and rule, 2011 of free and compulsory education of the children (serial-2).
3. School will admit 25% of poor students out of total intake from nearby in first standard (or in the next classes which is implemented) under the free and compulsory education and will inspect the same on its completion.
4. That as mentioned in para 3 the school will be bound to do the

fulfillment of expenses of children under rule 12 of sub rule (2).

The school will maintain the separate bank account for fulfilment of the same.

5. Institution/School will not get any capitation fees or school will not adopt any policy to choose surplus child or his parents.
6. School shall not refuse to admit any child due to non availability of birth proof and will comply with the terms and conditions of rule 15 of the Act. The school shall make ensure that (a) None of the admit child will not keep return in the class or will not expel from the school until and unless the child complete his primary education (b) None of the child will punish physically or mentally. (c) None of the child shall have any need to pass board examination till the completion of primary education. (d) Certificate under rule 25 will be given to the every student who has got completed his primary education (e) Joining of particulars / disabled students is necessary as per terms and conditions of the Act (f) It is mandatory for the teachers that they have to complete the minimum qualifications as mentioned under rule 23(2), but it is condition that the present teachers who don't fulfil the minimum qualifications from the date of implementation under rule R.T.E. (Amendment) Act 2017 since 01 April 2015, they would complete their minimum qualifications within one year (dated 31st March, 2019) (g) All the teachers would perform their responsibilities under Teachers Act Rule 24(1) (h) The teachers would not busy themselves in the private tuitions.
7. The school will pursue the subjects of education as prescribed by the higher authorities.
8. School will comply with the prescribed terms and conditions of rule 19 of the Act.



(a). Total area of the school covered by boundary walls is 40518 sq. fts and under building construction area comes to 21862 sq. fts. In this school there is 28 trained teachers and one School Head (b). Society of the school is constituted.

13. This school is not being run for any personal benefit, society or for the benefit of anybody else.

If the school/institution is found to violate the terms and conditions of rule/ norms prescribed by the department or any competent authority or if the concerned school found that the approval has been received by way of concealment of facts, then the approval of the school will be suspended/terminated.
